

Cambridge City Council Meeting Minutes
Monday, October 7, 2019

A regular meeting of the Cambridge City Council was held on Monday, October 7, 2019, at Cambridge City Hall Council Chambers, 300 3rd Avenue NE, Cambridge, Minnesota, 55008.

Members Present: Mayor James Godfrey; Council Members Kersten Conley, Lisa Iverson, and Bob Shogren. All present, no absences.

Staff Present: City Administrator Woulfe, Police Chief Schuster, Community Development Director Westover, Utilities/Public Works Director Schwab, Economic Development Director Stan Gustafson, Finance Director Caroline Moe, and Emergency Management Director/Deputy Fire Chief Pennings.

Others present: Clay Montgomery

Call to Order, Pledge of Allegiance, and Approval of Agenda.

Godfrey called the meeting to order at 3:30pm and led the public in the Pledge of Allegiance. Godfrey asked for a moment of silence to honor former Mayor and Councilmember Marlys Palmer who passed away on September 26, 2019.

Conley moved, seconded by Iverson, to approve the agenda as presented. Motion carried unanimously.

Consent Agenda Approvals

Shogren moved, seconded by Conley, to approve consent agenda items A-E as follows

- A. Regular and Summary City Council Meeting Minutes for September 16, 2019
- B. Draft August 2019 Financial Statements

Upon call of the roll, Godfrey, Shogren, Palmer, Iverson, and Conley voted aye, no nays. Motion carried.

Work Session

Lead/Copper Tap Water Monitoring Report

Utilities Director Todd Schwab updated the City Council about the recent Lead and Copper Tap Water Monitor Report and the testing that was done recently. This testing is done every three years in

various homes that meet certain criteria for the household plumbing they contain. The Monitoring Report results concluded that there were no exceedances for lead or copper in any of the homes tested.

Schwab stated that the positive findings are a result of not having corrosive water that could leach any lead or copper into the water, and that the City of Cambridge has been proactive in replacing outdated water mains and parts. The findings of this report have been mailed to the homeowners, and will also be published in a press release. This information will also be included in the Consumer Confidence Report that is posted yearly in June.

Unfinished Business

Sidewalk Mural Program

City Administrator Lynda Woulfe stated that public art creates a social connection for the community. Artists have a public place to share their art and the community has the ability to come together to appreciate the art. Creating a public art walk can also encourage tourism and get people out walking in our community. Woulfe also listed reasons why public art matter such as economic growth and sustainability, attachment and cultural identity with a location, artists as contributors to the community, social cohesion and cultural understanding, and public health benefits and belonging.

The City staff will create a panel of artists and art instructors to review and make recommendations to the City Council for projects to approve. Applicants and designs will have to meet certain eligibility requirements to be approved. A local artist, Hanni Carlile, shared with the council what a possible art project and design could be and look like, using the sidewalk by the new library for inspiration. There would be no tax dollars used for the art projects, with the exception of staff time to apply for the grants. Artists would be responsible for the maintenance and touchup, but the supplies would be covered by grants.

Concerns were raised about drivers slowing down to look at the sidewalk art. There was agreement that the art should be facing away from the street. Shogren also expressed concerns about the eligibility requirements for the art being too restrictive and it could subject the City to litigation if a person or group is denied participation. It was noted that the paint is special paint that will last 2-4 years, and paintings can be changed if needed.

Conley moved, seconded by Iverson, to pass the Sidewalk Mural Program. Motion passed with Conley, Iverson, and Godfrey all voting aye, and Shogren being the only nay.

New Business

LED Lighting Retrofit for Northbound Liquor

In finding ways to reduce the City's carbon footprint where financially possible, Northbound Liquor has received two proposals to switch the indoor and outdoor lighting fixtures to LED. Innovative Alliance had a proposal of a two-bulb fixture installation at a cost of \$17,795. Light the Lamp LED has a four-bulb proposal of \$13,371.06. Northbound Liquor Manager Bobbi Mix stated that she preferred the two-bulb quote from Innovative Alliance, even though it was the higher option. She felt that it

would have a better look and layout for the store, and would save more money into the future by only using two bulbs instead of four.

Discussion commenced about the various costs and options between the two proposals. Concern was raised about the cost of the new light bulbs themselves. Council members felt like they needed more information before they could make a decision.

Shogren moved, seconded by Iverson, to table the discussion. Iverson, Shogren, and Godfrey all voted aye, with only Conley voting nay. Motion carried.

Ord. 703 Amending Title V Public Works, Chapter 50 Garbage and Refuse, Section 50.04 Containers and 50.01 Definitions

Community Development Specialist Carri Levitski addressed the council about complaints and feedback she has received from citizens about the number of waste containers and their storage within city limits. Currently, residents may have up to four containers, with only two of them being visible. The visible containers must be in front of or adjacent to the garage, while additional containers must be screened from view.

Levitski proposed an amendment to Ordinance 703, specifically Sections §50.04 Containers, and Section §50.01 Definitions. The amendment would allow residents to have more than four containers. Residents will also be allowed three visible containers, but they will still need to be in front of or adjacent to the garage. Additional containers would need to be screened from view. Residents having more than four containers would need to store the extra containers in an enclosed building.

Councilmembers requested clarification on when screening would be required for containers. Levitski stated that if you have more than four containers screening is necessary. Shogren and Iverson stated they wanted to make citizens knew what to do to be in in compliance.

Conley moved, seconded by Godfrey, to adopt Ordinance 703 as presented pertaining to garbage and waste containers. Upon call of roll, all members voted aye, with no nays. Motion passed unanimously.

Consider possible abatement of 601 Railroad St. S.

A letter was sent, by Community Development Specialist Carri Levitski, that directed the property owner of 601 Railroad St. S. to demolish and remove the grain bin foundations on the property. Levitski noted that staff has been working with Clay Montgomery regarding the removal of the foundations. Levitski stated that decades ago this property was a feed mill and that Sam Montgomery, Clay's father, purchased the property from Burlington Northern Santa Fe Railroad in January of 2000.

Montgomery informed staff the property has not operated for 30 years and his father took the grain bins down after purchasing the property. Clay's niece has inherited the property and is in college out

of state but stated they are committed to keeping the property in a safe condition.

Levitski noted that Building Inspector Matt Small inspected the property the last week of August and reported the foundations are sound and are not hazardous. During the inspection, Matt did find areas that needed attention and Clay is working on securing those areas that we have identified. They were not aware of these areas until notified by the City.

Montgomery asked if the city is interested in the property and the Council stated they were not interested because there is no infrastructure available.

Montgomery stated the family feels the grain bin foundations are not creating a problem or blight since the area is undeveloped. The family received a quote for \$65,000 to remove the foundations. According to the 2019 tax statement, the property is valued at \$22,300.00. The family feels the property is not worth the cost to remove the foundations.

Woulfe stated the City's main concern is that the property remains safe and is no longer hazardous. They were not as concerned with the appearance of the foundations on the property, as it remains in an undeveloped area that is not easily seen. Montgomery informed the City Council that he has secured the areas that were in need of attention. In light of this new information, the City Council no longer feels that the property is a nuisance or contains any hazards.

Godfrey moved, seconded by Shogren, not to proceed with abatement as long as the property remains in a safe condition and no hazards exist. All council members voted aye with no nays. Motion passed unanimously.

Lexipol Policy Update

Chief of Police Todd Schuster presented updates for the department's Lexipol policy manual. Schuster noted updates are sent when it is required due to Federal or State law changes, major court decisions or just changes in "best practices".

Schuster noted that applying and adopting these recommended updates in a timely manner minimizes liability to the officers, department and city. We received a number of recommended policy updates at the end of August and he applied the appropriate updates. Some of the updates were major overhauls of existing policies and others were just grammar-related changes. Below is a brief synopsis of the updates that were applied:

Policy 302: Handcuffing and Restraints. All of the updates were Best Practice suggestions.

Policy 320: Standards of Conduct. This update was a major overhaul due to new legislation regarding conduct by officers. The policy now conforms with the MN POST Board model policy.

Policy 327: Registered Predatory Offenders. Added a change in the notification process due to a change in the state statute.

Policy 343: Professional Conduct. This policy was deleted and incorporated into the new language in Policy 320.

Policy 410: Civil Commitments. Changed language in 410.3. Authority to make an involuntary commitment used to be based on an officer's reasonable suspicion. State law language was changed and now requires probable cause.

Policy 427: Medical Aid & Response. Changed some Best Practice language and added language on the administering of opiate antagonists, should we begin delivering such medications. All of the language states that the user must be trained and qualified, so the language is merely for possible future use.

Policy 601: Sexual Assault Investigations. This update was a major overhaul of the prior policy. A new model policy was adopted by the MN POST Board. This policy now conforms with the model policy. Every law enforcement agency in Minnesota was required to submit their updated policy and a letter to certify that we adopted the policy to the POST Board.

Policy 1000: Recruitment & Selection. Updates were Best Practice suggestions and added a section in relation to Probationary Periods.

Policy 1004: Anti-Retaliation. Added language protecting employees from "Whistle-Blowing" in accordance with MN Statute.

Schuster clarified a few questions about the new policies. Conley moved, seconded by Iverson, to adopt the Lexipol policy changes as presented. Godfrey, Iverson, Shogren, and Conley all voted aye, with no nays. Motion passed unanimously.

Request by Brian Baas to Construct a Private Well at 3129 Airport Parkway

Utilities Director Todd Schwab presented that on 9/30/2019 staff received a request from Brian Baas, a hanger owner at the Cambridge Municipal Airport to construct a private well at the site of Mr. Baas' new hanger located at 3129 Airport Parkway. The well will be used to supply water to the bathroom facilities located in the hanger.

The city water system does not extend to the Airport and is not scheduled to be extended to the Airport property in the near future, so a private well would be necessary to supply water to the site. City Code section § 51.16(D) addresses what procedure needs to be followed in such instance. The section reads as follows:

(D) In cases of extreme hardship, an owner may request an exemption from the City Council to construct a private well. For the purposes of this chapter, Hardship shall be defined as the City's water main being greater than 300' feet away from the parcel. In allowing an exemption, the City 16 Council may apply special conditions as benefits the health and safety of the City. The hardship will no longer exist once the water main is extended past the property and the owner will be required to connect to the City's water public supply.

Shogren inquired if a septic system was also needed. Schwab responded that a holding tank would be used. The property would be connected to city water and sewer at a later date as infrastructure improves.

Shogren moved, seconded by Iverson, to adopt Resolution R19-067 as presented. All council members voted aye, with no nays. Motion passed unanimously.

Mayor's Report and Council Concerns

Sandquist Park parking concerns – enforcement

City Council member Bob Shogren discussed how he had concerns about who was in charge of enforcing the parking at Sandquist Park. City Administrator Lynda Woulfe explained that the Isanti County Sheriff's Department is in charge of enforcing the roads near the park, but the Cambridge Police Department is in charge of enforcing parking within the park itself, as the city owns the property. There is no contract between the two agencies, as the enforcement is defined by city ordinance. No further discussion or action was needed.

Shogren moved, seconded by Iverson, for a 10-minute break from 4:33 to 4:43 pm. Motion carried.

City Administrator's Report

The City Council temporarily adjourned into closed session at 4:43pm. This portion of the meeting was closed, under Minnesota Statutes §13D.05, to consider an offer for property located on 3rd Ave NE (next to Aldi) PIN15.992.0030.

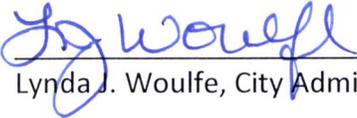
Adjournment of Council Meeting
