Cambridge City Council Meeting Minutes Monday, April 4, 2022

A regular meeting of the Cambridge City Council was held on Monday, April 4, 2022, at Cambridge City Hall Council Chambers, 300 3rd Avenue NE, Cambridge, Minnesota, 55008.

Members Present: Mayor James Godfrey; Council Members Lisa Iverson, Kersten Conley, Mark

Ziebarth (arrived late), and Bob Shogren.

Staff Present: City Administrator Vogel, City Attorney Squires, Police Chief Schuster, Finance

Director Moe, Utilities/Public Works Director Schwab, Assistant Public Works Director/Airport Manager Milz, Community Development Director Westover, City Engineer Blank, and Emergency Management Director/Deputy Fire Chief

Pennings.

Call to Order and Pledge of Allegiance

Godfrey called the meeting to order at 5:00 pm and led the public in the Pledge of Allegiance.

Approval of Agenda

Godfrey noted the addition of items 4G – Offer Letter to Part-time Receptionist, 4H – Purchase of City Property by Leaf's Towing, 5B – Discussion of Meeting Times, and 5C – Proceeds from the Sale of Land. Iverson moved, seconded by Conley, to approve the amended agenda. Motion carried unanimously.

Consent Agenda

Shogren moved, seconded by Iverson, to approve consent agenda Items A-H:

- A. Approval of the regular and summary meeting minutes for March 7, 2022 and March 21, 2022 City Council meeting
- B. Draft February 2022 Financial Statements
- C. Resolution R22-023 Authorization to Execute MNDOT Grant Agreement 1048160 for Airport Improvement-SP 3001-41
- D. Approve new contract with Rum River Construction Consultants
- E. Airport Advisory Commission Members
- F. Approve Storm Water Maintenance Agreement with Cambridge Christian School
- G. Approve Offer Letter to Part-time Morning Receptionist
- H. Approve Purchase Agreement with Leaf's Towing for City-owned Property

Upon roll call, Godfrey, Shogren, Iverson, and Conley voted aye, no nays. Motion passed unanimously.

Work Session

MPCA Certificates of Commendation

Schwab stated the Minnesota Pollution Control Agency (MPCA) has commended staff for their exemplary effort in the year 2021. He stated staff complied with the MPCA National Pollution Discharge Elimination System/State Disposal System (NPDES/SDS) wastewater permit program.

Schwab said staff received another award for 2019, but the conference was not held in 2020 due to COVID-19. He noted these are the 12th and 13th awards that staff has received for their efforts.

Discussion of Meeting Times

Vogel said the start times for meetings had been questioned, and an ordinance amendment would be required to change the start time. He inquired with the council on what they would like the start times to be, and Shogren felt the City Council and EDA meetings should all start at 6:00 pm. He said the seconded meeting on the month would have the EDA meeting starting at 6:00 pm with the City Council meeting immediately following. Conley felt they should keep the EDA meetings at 5:45 pm so that both City Council meetings could be starting at 6:00pm for consistency. Iverson noted the seconded meeting used to start with the EDA first, and then had the City Council meeting start immediately thereafter for many years. Vogel said he would prepare an ordinance amendment and bring back to the council at a future meeting.

Proceeds from Sale of City-Owned Property

Vogel stated they have a signed purchase agreement from Leaf's Towing to purchase land in the Cambridge Opportunity Industrial Park. He said the funds from the sale are currently undedicated, but thought it would be prudent to put the funds into the EDA Acquisition Fund to purchase additional industrial land in the future. Iverson asked if any of the proceeds need to go to parks, and Vogel stated none was needed. Moe added they need to have it on record of where the funds from the sale need to go. Shogren was concerned about the business friendliness in Minnesota, and felt the funds could be used for other things than purchasing more land. Vogel added there is only enough land left in the industrial park for two other projects. He said it would be good to continue to acquire additional land for the future. Shogren asked if the discussion could be set aside, and Godfrey added they could include it in the Budget discussions later in the year. Moe stated the first of these discussions would be held on June 6, 2022 at 4:00 pm, two hours before the City Council meeting that same night. Discussion dissolved.

Unfinished Business

There was no unfinished business.

New Business

2021 Audit Report Presentation

Moe introduced Dave Mol, an audit partner from Redpath & Co., to present on the 2021 audit report for the City of Cambridge. He provided an overview of the report, and then went on to explain different parts of the audit report including various financial activities, taxes, debts, the general fund and expenditures. There were no findings of noncompliance. Mol noted the City of Cambridge has received the Certificate of Excellence for Financial Reporting for 2020. This is the 19th year the city has received this award. Godfrey thanked Moe and the finance department for their hard work, and then Moe present Mayor Godfrey with the award plaque.

Resolution R22-024 Call for the Sale of Bonds to fund 2022 Street Improvement Project

Moe informed the council that a call for the sale of bonds is recommended to finance the 2022 Street

Improvement Project. She said there was already a public hearing last summer for the 2022 Street

Improvement Project and the sale of the bonds. The sale would be done by Ehlers on May 2, 2022 for
no more than \$4,555,000 of bonds. Shogren moved, seconded by Iverson, to approve Resolution

R22-024 to call for the sale of the 2022 General Obligation Bonds to fund the 2022 Street Project. Motion passed unanimously.

2022 Cambridge Municipal Airport Construction Project

Milz introduced Lindsay Reidt from SEH to provide information about the 2022 Cambridge Municipal Airport Construction Project. She stated the project would include reconstruction of the runway, new edge lighting, and new signage. Two alternates included with the bids include reconstructing the taxiway turnaround and adding LED edge lighting to the taxiway turnaround. Reidt said the project won't start until 2023, after the federal and state grants have been received. Seven bids came in for the project, and the low bid for the project came from Minnesota Paving && Materials. Reidt stated the total cost of the project with alternates and engineering is \$2,007,857.15. FAA is funding \$1,778,315.81, MnDOT is funding \$121,160.81, and the city is funding \$108,308.53 of the total project costs. Ziebarth moved, seconded by Iverson, to approve the bid from Minnesota Paving and Materials for \$1,737,457.15. Shogren asked if the city has worked with the company before, and Milz stated they have done other projects for the city. Milz also wanted to make sure the motion includes approval of the Professional Services Agreement from SEH and acceptance of the IFE results. Godfrey asked if Ziebarth and Iverson were okay with amending their motions to include these items too, and both Ziebarth and Iverson confirmed that they were okay with amending the motion. Godfrey asked for roll call on the amended motion, and the motion passed unanimously.

Mayor's Report

Godfrey wanted to engage the community for input on suggestions for improving the downtown area. He wanted to call it "Cookies with Council", and hold these input sessions in conjunction with the Third Thursday events in June, July, and August. Vogel said staff will also be connecting with businesses to gather their input too to help with restoring and revitalizing the downtown area. Shogren was concerned about how the input will be used, and Vogel said the input from last year helped with their strategic planning discussions. Shogren and Iverson approved of these input sessions, but wanted to know about other options for reaching to residents for input too. Vogel said he would make up schedules for council to sign-up for the sessions.

Council Concerns

There were no council concerns.

City Attorney/City Administrator's Report

Vogel said he has been asked to speak at the Cambridge Medical Center Board meeting to update them with information about the city. He also updated the council with dates for budget discussion meetings on June 6th at 4:00pm, August 15th at 4:00pm, September 6th at 5:00pm, and November 21st at 4:00pm. Vogel also noted the Truth in Taxation meeting will be held on December 1st at 6:30pm, and the approval of the final tax levy and budget set by the council will be on December 5th.

Vogel stated they would need to enter into a closed session under Minnesota Statute 13D.05, subsection (3), item (1) to develop or consider counter offers for the sale of city-owned property with PID 15.291.0020. Iverson moved, seconded by Shogren, to enter into a closed session. Motion passed unanimously, and the session was closed at 5:15 pm. After discussion, Shogren moved, seconded Conley, to move back into open session. Motion passed unanimously, and the session was opened at 6:09 pm.

Knife River has constructed many projects in this area for Counties and MnDOT, and they do most of the asphalt paving for City projects. Based on this and information proved by them and their bonding company, we conclude that Knife River should have the experience, equipment and ability to successfully complete this project.

Accordingly, staff recommends the project contract be awarded to Knife River in the amount of \$4,261,953.74, which is less than the engineer's estimate shown above.

SEH is pleased to submit this proposal for construction engineering services for the 2022 Street Improvement project. These improvements are defined in the construction plans dated March 21, 2022. Bids were opened on April 14, 2022 and construction is anticipated to begin in May. The low bidder is Knife River Corporation.

These services consist of preconstruction coordination, on-site observation by Resident Project Representatives (RPRs), construction staking, construction administration, project close out and record plan preparation. Based upon a construction in early May and using the work completion date of late September, we have estimated a 24 week construction period.
