Cambridge City Council Meeting Minutes Monday, September 18, 2023

A regular meeting of the Cambridge City Council was held at Cambridge City Hall Council Chambers, 300 3rd Avenue NE, Cambridge, Minnesota, 55008.

Members Present: Mayor James Godfrey; Council Members Lisa Iverson, Aaron Berg, Mark

Ziebarth, and Bob Shogren.

Staff Present: City Administrator Vogel, Police Chief Schuster, Finance Director Moe, City

Attorney Squires, Development Director Westover, Utilities/Public Works Director Schwab, Assistant Public Works Director Milz, City Engineer Schmitz,

and Assistant to the City Administrator Seiberlich.

Closed Session

Godfrey called the meeting to order at 6:20 pm and led the Pledge of Allegiance.

Citizens Forum

Aliesha Larson, 345 Rosevelt St. S, Unit H, spoke on parking issues cause by winter parking restrictions. She said many people in her neighborhood park on the streets because their driveways are small. She has three children that drive and all the vehicles do not fit into her driveway. Previously, they were able to park on a nearby dirt cul-de-sac, but recently lost that ability leaving them with nowhere to park once winter parking restrictions go into effect on October 31st. Larson provided photos for staff to review.

Approval of Agenda

Iverson moved, seconded by Shogren, to approve the agenda.

Ziebarth requested to add 10A Service Delivery League Update under Council Concerns. Iverson and Shogren agreed to approve amended agenda.

All voted aye, no nays, motion passed unanimously.

Upon roll call, Godfrey, Shogren, Ziebarth, Berg and Iverson voted aye, no nays. Motion carried unanimously.

Work Session

A Cambridge Airport Advisory Commission Discussion

Milz said the Airport Advisory Commission was formed in 2018, Council re-organized the commission to limit the amount of non-city residents that could be appointed. The purpose to assure those advising the Council of financial expenses be cognizant of the city's budget.

Milz continued, the current Commission is operating at a bare minimum due to a recent resignation of a long-standing member. The Commission has requested to increase membership and allow more members from outside city limits. After discussion of this request, staff feel it is best to change the meeting structure to an annual town-hall style meeting that can involve Council, hanger owners, pilots, and airport users.

Shogren asked if everyone would have a vote at the town-hall style meeting, Milz said staff envisioned an open forum to discuss status and gather input rather than taking a vote. Any voting done now brings recommendations to Council, then goes to FFA or MnDOT for review. Staff feel gathering input to bring to Council is sufficient.

Ziebarth stated he sits on the commission as a Council Representative and thought the staff recommendation was appropriate. Commissioner input is valuable, but could be accomplished in an annual town-hall style meeting.

Vogel noted he supports the proposal. Meeting attendance has been a challenge and expanding memberships has proven difficult in the past. This would provide an opportunity to engage hanger owners annually to gather valuable input, as well as reduce staff time.

Godfrey said the airport recently went through a major renovation and it will be 20-30 years before serious input would be needed again.

Squires noted there would need to be a change to the city code.

Ziebarth motioned, seconded by Shogren, to de-commission the Cambridge Advisory Commission covered under Ordinance 683 and direct staff to organize a yearly town-hall style meeting to take its place, and draw up required ordinance changes. All voted aye, no nays, motion passed unanimously.

Ziebarth thanked Milz for being a dedicated Airport Manager.

B Presentation from David Drown and Associates (DDA) on Class and Comp Study

David Drown Associates (DDA) representative Tessa Melvin presented findings from the recent Class and Comp Study. The study compared benchmark cities that were selected by staff, including one spotlight city. The study found the city's current rate is 7% under average minimum rate, at market average maximum pay, and some jobs were 10% under market.

Melvin continued, the pay philosophy was based on how the city wants to pay compared to the market. At a previous meeting Council discussed being in the 85th percentile, which would leave two to three entities above the city. For comparison, the 100th percentile means city would be at the top of the pay scale.

Godfrey asked if the jobs that were 10% below market rate were specific to any job group, Tessa replied it was scattered through the organization. Vogel noted there were four to five positions that were 10% or more below market, which would be corrected with Moe's proposal. Most of the positions were entry level Police Officer salary. Tessa said that was not uncommon, licensed position salary was going up and the system had yet to catch up.

Unfinished Business

A1 2024 Preliminary Tax Levy Adoption

Moe noted the 2024 budget draft already had placeholders for expected salary increases and would be able to implement the desired 85th percentile in 2024 for all staff without affecting budget. This is important to recruit new staff and retain current staff. Staff recommend a preliminary 11% tax levy increase, which still decreases the overall tax rate by 3.88%.

Moe noted she does not feel they will need the full proposed levy increase at final adoption in November, and felt it will be closer to 9%. She reminded Council that the budget is still a work in progress and it is important to plan for a little wiggle room when adopting a preliminary levy.

Berg motioned, seconded by Shogren, to approve Resolution R23-086 2024 Preliminary Levy as presented.

Godfrey asked Schuster if the four officers that turned down thier job offer was due to low pay, Shuster replied that was correct. Godfrey noted that approving the 11% levy could help fill the open officer positions.

Upon vote, all voted aye, no nays. Motion passed unanimously.

Vogel noted with Council's approval of the preliminary levy of 11% and an understanding of Councils pay philosophy, he would reach out to the bargained units to start to work with them to meet the January 1 schedule. Vogel thanked Council for listening to staff, their action shows dedication to hiring and retaining the best talent and shows appreciation to the existing talent.

A2 2024 Preliminary General Fund Budget

Berg motioned, seconded by Iverson, to approve R23-087 2024 Preliminary General Fund Budget as presented. All voted aye, no nays. Motion passed unanimously.

New Business

A 2024 Street Improvements

Schmitz said the 2024 project consists of improving the streets and underground utilities located on: East Rum River Dr from Central Ave to 32nd Ave SW; Norway Circle west of South Laurel St; South Laurel St from Central Ave to 32nd Ave SW; South Kenwood St from Central Ave to 32nd Ave SW; Kenwood Ct north of 34th Ave SW; Kenwood Pl south of 34th Ave SW; South Juniper St from Central Ave to 34th Ave SW; South Ivy St from Central Ave to 32nd Ave SW; South Holly St form Central Ave to 32nd Ave SW; Central Ave from East Rum River Dr to South Main St; 32nd Ave SW from East Rum River Dr to South Juniper St; East Rum River Cir from Polk St to Polk St; East Rum River Ct to Rum River Cir.

Streets included in the 2024 plan are 32-35 years old, the pavement is failing, much of the curb is deteriorating, some retaining walls need work, and a trail connection would be made. There are plans to add additional lighting, to add on-street trail connection for the C-I Trail, as well as a planned sidewalk on the south side of 32nd Ave. There has been opposing feedback from residents regarding the sidewalk on 32nd Ave, which is part of the city's overall sidewalk plan and needs council approval to move away from that. It is also planned to widen Ivy St by allowing no parking on one side of the road, widening road, and constructing an on-street trail connecting part of the C-Trail. Kenwood Pl would keep the existing curb and only be repaved.

Schmitz stated this is a large project and generally completed in 2-3 phases. The project should be completed by September and disruption should be minimal. The total estimated project cost is \$7.3 million and project funding consists of 83% gas tax funds and 17% special assessments to the 211 adjacent properties that benefit from the improvements. Assessments should be \$6,000 or \$4,200, depending on the street.

Schmitz said if the proposed resolution is approved by Council, the Process and Assessment Hearing would be scheduled for Oct. 16th. Then plans would be ordered, go through the design process, open bids in April, and start the project in early May.

Vogel requested Council feedback regarding the sidewalk on 32nd Ave. Staff have received several written petitions and oral feedback voicing concerns about the sidewalk. While Council can make decision on Oct. 16th at the public hearing, discussion and feedback earlier will help plan the budget. This has been a Council goal for a long time to provide a connection to the Cambridge-Isanti bike-walk trail as well as safety improvements for pedestrians.

Godfrey asked if 32nd was a heavy traffic road, Schmitz said traffic was low enough to reasonably walk on the street. Godfrey said he felt the city does not need it, the residents do not want it, and it would save money on the project to not include it.

Ziebarth noted a sidewalk was recently installed on 24th and on 28th that run east to west. Traffic is less on 32nd, but there is no way to access the major points without being on road. Any decision made should consider long-term growth as this project will likely last 25-30 years. It is an easy decision to not install the sidewalk, as it saves money and makes residents happy, but what is the long-term plan for the area? He wanted to voice the other side of the project and look into the future.

Godfrey felt there were no buildable areas in that part of town, Vogel stated as the city grows it is possible for more residential lots on Central. The neighborhood is established and does not have much room for growth, but some growth is possible.

Shogren said years ago it was standard to have a sidewalk on both sides of the street, it was hard for Council to change to having a sidewalk on only one side of the street. He asked if 32^{nd} was considered a collector street, Schmitz replied it was. Shogren said other collector streets have sidewalks as should this one.

Shogren asked why there was no curb planned on for East Rum River Circle, Schmitz said a storm sewer system would need to be installed, which would be costly and change landscape of neighborhood. Shogren felt Polk Street would be an area for growth in the future and to consider this when planning the street project.

Iverson asked if there were areas for potential future development that would impact 32nd, Vogel said the areas for growth are minimal, but not nonexistent. There is some vacant land on 32nd but most of the area is built out. Any annexation to south could offer more low-density residential but nothing significant. Schmitz noted if growth occurs to the south, it likely would not impact 32nd. Iverson asked the estimated sidewalk cost, Schmitz said it was estimated to cost \$150-250,000.

Godfrey asked if both cost options could be presented at the public hearing on October 16th, Schmitz replied they could. Vogel reminded Council that they did not need to make a decision, but it would provide direction and clarity to staff.

Iverson how many homes are on 32^{nd} versus how many complaints the city received, Vogel said there were 14 homes on the south side, but could not verify if the petitions came from residents in the neighborhood as a whole, or from those on the south side of 32^{nd} . Schmitz said all but one of the petitions came from residents on 32^{nd} . There is one property not in city limits that the sidewalk would affect.

Ziebarth past decisions to reroute a sidewalk was determined by less disruptive options, 32nd does not offer less disruptive possibilities. He expressed concern about the property that is not in city limits.

Shogren asked if the property located in the township would be assessed the same, Vogel answered the city did not have authority to assess the property, but there are financial incentives for the homeowners to voluntary pay assessments for improvements. The city can put an assessment on a property with no obligation to pay until the property is annexed or sold, but interest would accrue over time. Squires agreed, stating the city would be able to attach an assessment that becomes active if a trigger event happens, such as being annexed or sold. The assessment accrues at 10% interest.

Shogren stated he felt the city's best interest would be to annex any affected properties into the city. Godfrey asked if staff could look into that option, Vogel thought the owner would likely object to that action.

Shogren motioned, seconded by Iverson, to adopt Resolution R23-088 Receiving Feasibility Report, and Order a Public Hearing and Assessment Hearing on October 16th. All voted aye, no nays, motion passed unanimously.

B, C, D & E PUD Amendment-Cornerstone Second Addition

Westover said the Cornerstone Addition plat consists of three parcels, one known as the former Perkins site, the parcel to the north, and the parking lot to the east. These parcels are part of a Planned Unit Development (PUD) that went into effect in 1999. When the Hwy 65 bypass was built state surplus land was conveyed to the city. The city sold the land to a developer in order to foster business growth in the area. The PUD had special terms including the land had to be a restaurant, the owner was responsible for plowing and snow removal of Rochester St NE/Harrison St. NE, and the parcel to the east of the building was only to be used for parking and drainage purposes.

The new developer, Compton Addy, has requested to amend the PUD. The site will still be three parcels: the existing building will be demolished and a new restaurant built, the next phase will be an automotive tire service shop, and the final phase use has yet to be determined.

Westover noted the Site Plan Review and Stormwater Maintenance Agreement must be completed and approved by city staff before any permits are issued. The previous covenants established in 1999 PUD will be amended with the new owner.

Westover continued, the developer has requested to vacate a portion of Harrison/Rochester Street that has an existing gas line beneath, in order to redevelop the site. The developer has been in contact with the gas company and are working on relocating the gas line. The Planning Commission felt it was important for staff to receive written approval from the gas company to relocate the gas line.

Godfrey asked if the restaurant could be named, Westover said it was planned to be a Chipotle and an unnamed auto body business.

Iverson motioned, seconded by Shogren, to approve resolutions R23-075, R23-076 as amended, R23-077 as amended, and R23-078 as amended. All voted aye, no nays, motion passed unanimously.

F Approve Squad Car(s) Purchase

Schuster said 364 days ago he requested approval to reorder a squad car that had been ordered at the beginning of 2022, and to order two additional squads for 2023. The police department has not taken delivery of any of those squad cars. On Monday the department was provided a quote of \$93,770 from Guardian Fleet Safety for two brand new Ford Explorer Police Interceptor Utility (PIU) vehicles that they were able to acquire. The units would replace the 2012 Chevy Tahoe and 2014 Ford PIU. The Tahoe in particular is starting to show its age and has been in more frequent need of mechanical repairs to maintain the safety required for a squad car.

Moe stated that there are sufficient funds in the Capital Replacement Plan to pay for the three squads that are on order, the two new ones, and upfitting them all with the necessary emergency equipment. Currently it is unknown when the three previously ordered PIU's will be delivered.

Berg motioned, seconded by Ziebarth, to authorize staff to purchase two Ford Explorer PIU's from Guardian Fleet Safety and upfit them with the necessary emergency equipment.

Shogren asked if the PIU's were painted to match the current vehicles, Schuster said they are painted black, the plans were for a different graphic than the department currently has. Staff was asked to find examples of squad car graphics they liked, and through a vote one design was chosen to be reworked at the graphic shop. Shogren asked how many different graphics were being used, Schuster said would be three with this new design.

On vote, all voted aye, no nays. Motion passed unanimously.

Mayor's Report

Godfrey thanked those that volunteered for Customer Appreciation Day. Vogel estimated about 4,000 to 5,000 people attended, with approximately 3,000 to 3,500 served food.

Council Concerns

A Update on the LMC Service Delivery Committee Meeting

Ziebarth noted he attended the Service Delivery Committee Meeting that morning. There is a task force that has been looking into EMS response times to make recommendations for the 2024 legislation. They had a discussion on issues cities are having with electric bikes. It was also recommended to make changes related to public meetings due to an increase of public disrupting meetings and causing issues conducting business. He said he was amazed at the work that goes into the Customer Appreciation Day and thanked those that volunteered their time and the generosity of local businesses.

Vogel updated Council that the SRO contract changes were being reviewed at the School District Meeting on Thursday, he stated he had no reason to believe there would be any issues with the changes and would provide updates as they come.
