Cambridge City Council Meeting Minutes Tuesday, February 20, 2024

A regular meeting of the Cambridge City Council was held at Cambridge City Hall Council Chambers, 300 3rd Avenue NE, Cambridge, Minnesota, 55008.

Members Present: Mayor James Godfrey; Councilmembers Lisa Iverson, Aaron Berg, and Bob

Call to Order

Godfrey called the meeting to order at 6:00 pm and led the Pledge of Allegiance.

Citizens Forum

No one signed up for the citizens forum.

Approval of Agenda

Iverson moved, seconded by Berg, to approve the agenda. All voted aye, no nays, motion passed unanimously.

Consent Agenda

Shogren moved, seconded by Iverson, to approve consent agenda Items A-I:

Upon roll call, Godfrey, Shogren, Berg and Iverson voted aye, no nays. Motion carried.

Work Session

A. Economic Development Annual Report

Smith presented the Economic Development Department's 2023 annual report. The responsibility of the Economic Development Department is to help support the economic growth within the City. This

can range from attracting new businesses, retaining current businesses, help with housing, and coordinating developers with resident's needs.

In 2023, Smith said, she was out on maternity leave for three months. She expressed appreciation to staff that helped fill in during her absence.

Smith stated the Downtown Revitalization and Restoration Program was a large project for 2023, and has been receiving positive results and feedback. Despite the struggles within the economy and industry, Cambridge has continued to receive interest from developers and business owners.

Smith said in 2023 she has been working with organizations such as Discover Downtown, Economic Development Association of Minnesota (EDAM), Career and College Community Collaboration (C4), North 65 Chamber of Commerce, East Central Regional Development Commission (ECRDC), Regular meetings with Amanda Usher with Isanti County, and Stephanie Hillesheim with the City of Isanti, Minnesota Department of Employment and Economic Development (DEED), Isanti County EDA, and regular meetings with local businesses.

Smith announced the new businesses for 2023: Happy Productions, Mondo's Pet Depot, Jayda Belle Boutique, Thistle & Ivory, Revel Roots, Venture North Media, The Babe Cave, Scooters Coffee, West side Kwik Trip, Popeye's, and Heppner Insurance. Businesses that expanded or remodeled include: Embrace Orthodontics, Tidal Wave, Cambridge Dental Center, Steve's Tire, Anoka Ramsey College, Cambridge Bar and Grill, and PHASE Industries.

Smith continued, Unique Apartments opened in 2023 with 48 units. Set to open in 2024 are Bridgewell Apartments with 65 affordable units, and The Lodge at Oak Landing with 148 units. There is an updated housing study underway by Maxfield that should be completed in 2024.

Smith recapped that the Downtown Revitalization and Restoration Program has been going well. A Wayfinding Study was completed in 2023, the Fire Suppression Program was created and implemented, there was an update to the Façade Grant, and the purchase of the former Woody's Parking Lot. In 2024 the Interest Rate Subsidy Program was created, there will be implementation of some recommendations from the Wayfinding Study, possibly including better labeling of public parking.

Smith said in 2023 two of the Downtown Programs were utilized. Cambridge Bar and Grill, Thistle & Ivory, and Happy Productions participated in the Fire Suppression Program, two of these buildings have already been sprinkled, one is seeking contractors. This enhances the safety and desirability of the buildings downtown. The updated Façade Grant was utilized by Cambridge Floral Building, Chilson's Jewelers, Cambridge Bar and Grill, and Adam Schorer for Introspect Mental Health.

The City Center Mall is growing, Smith noted. Mondo's Pet Depot and Jayda Belle Boutique are new in 2023. All the suites are occupied except one, which has serious interest. On average there are two to four events in the Mall Corridor each month such as: Winter Farmer's Market, SAC's events, job fairs, Chamber of Commerce events, sports cards and collectables, and the Snowflake parade.

There were two TIF agreements put into place in 2023. TIF 6-23, the Cambridge Family Apartments, aka Bridgewell Apartments, and TIF 6-25, Strong Oak Apartments, aka The Lodge at Oak Landing.

Smith summarized what to expect for 2024 and beyond. There will be more improvements to the Downtown Revitalization programs; Increased efforts in marketing city owned spaces, completion of two TIF housing projects that will add up to 300 new units, continued collaboration with the community in and around Cambridge, and the results of the Housing Study by Maxfield.

B. Police Department Annual Report

Schuster said the Cambridge Police Department consisted of the Chief of Police, Deputy Chief of Police, two Sergeants, eight Full-Time Patrol Officers, and two Part-Time Patrol Officers that help cover shifts when available. There two current openings with one more anticipated due to an internal assignment from Officer to Detective. There is one Criminal Detective and two School Resource Officers. One Police Administrative Assistant and one Police Permit Technician handle all the behind-the-scenes work.

Schuster continued, the department is staffed 24 hours per day 365 days per year, providing proactive policing patrols and response to calls. To accommodate this there are two 12-hour patrol shifts per day, where two Officers are scheduled from 6:00 am to 6:00 pm and two Officers work 6:00 pm to 6:00 am. Once the department is fully staffed, it is planned to have two officers work opposite days and overlap the day and night shifts. Both Sergeants work night shifts and are assigned to one of the rotations. The department strives to maintain two Officers on duty at all times, but due to vacation, sick leave, training, and court time, there may be only one Officer on duty periodically. Part-Time Police Officers help reduce the number of times this occurs.

2023 brought the retirements of three officers, Jesse Peck, Jason Harvey, and Jenni Caulk. In September Schuster announced his own retirement, effective June 2024. These departures created an opportunity to hire new employees. Officers Tyler Johnson and Derek Gregorich were hired in 2023, both of whom have successfully completed Field Training and are now on solo patrol.

Shuster said the department ramped up its officer wellness partnership with Blue Peak in 2023. All officers were required to participate in an in-person "check-up from the neck up" which provides a variety of services for Officers. Blue Peak is on site quarterly for Officers to talk to in person, and there are also monthly online meetings for himself and Deputy Chief Machin.

A lot of new equipment was needed in 2023, Schuster said. Due to new FBI and BCA mandates, new portable and mobile radios that are dual-encryption enabled needed to be purchased. State Legislation changed to require Officers to carry Naloxone, commonly known as NARCAN. NARCAN is an opioid antagonist, or a medication that can reverse the effects of an opioid overdose. Thanks to a very generous donor, a grant administered through the University of Minnesota allowed the department to get new AED's for all the squad cars for no cost to the City. Duty weapons were equipped with optics, the department recently trained with these and accuracy had increased across the board.

Some of the Community Policing Initiatives for 2023 included business checks that occur every day, National Night Out, Downtown Customer Appreciation, Snowflake Parade, Coffee with a Cop Hosted by McDonalds, Shop with a Cop, and more.

Schuster reviewed 2023 Statistics compared to 2022: the total ICR's created were 23,066, slightly up from 2022; there were 979 adult arrests and 51 Juvenile Arrests, both down from 2022; business and security checks were up at 11,801; community policing details were slightly down at 1,510; Permit to Purchase applications were down in 2023 at 72; and traffic stops remained about the same.

Schuster said looking ahead into 2024, the city has been proactive in getting the future administration in place with his upcoming retirement in June. Deputy Chief Machin will take over as Chief of Police, and Detective Tanner Hagen will take over as the Deputy Chief of Police. Officer Erickson has been named the Isanti County Law Enforcement Association Officer of the Year for 2023. The annual banquet will take place on February 29th where he will accept the award. He won this award for his dedication to removing intoxicated drivers from our roadways. He was also nominated for a "DWI All Star" through the MN DPS, but will not know until March if he wins this award.

The department is currently sending two potential candidates through the background investigation process to determine if they are suitable to continue in the preemployment process to fill the open positions. Finally, the entire county is supposed to be online with Oracle, who is providing the new CAD / RMS / Mobile / Jail software.

Unfinished Business

A. Approve Ordinance 783 Dissolving Airport Commission

Vogel said in September the City Council heard a presentation from Milz regarding ongoing problems with membership for the Airport Commission. After some discussion, the Council was supportive of dissolving the Airport Commission, provided that Milz hold an annual meeting with hangar owners. Ordinance 783 is a delete-all ordinance that will dissolve the Airport Commission.

Shogren asked if decisions made at the annual meeting were binding or would they be considered advisory, Vogel said they would be considered advisory, the meeting function would be to provide communication between hanger owners and City staff, and ultimately, Council.

Godfrey verified this Ordinance had been reviewed by the City Attorney, Squires said he had reviewed and approved it.

Shogren motioned, seconded by Iverson, to approve Ordinance 783 dissolving the Airport Commission and allow for a summary publication. All voted aye, no nays, motion passed unanimously.

New Business

A. Approve Contract for the Airport Apron Construction Project

Lindsay Reidt, Lead Airport Engineer with SEH, presented the contract with SEH for the proposed 2024 apron reconstruction at the airport. This project includes reconfiguration of the airplane tiedowns, replacing pavement and new pavement striping. This project would be contingent on getting a grant through the FAA before moving forward.

Godfrey asked if this was a 90/5/5 percent grant, Reidt said it was, 90 percent would come from FAA, 5 percent would be funded by the State, and 5 percent would be local funding. This project has some items not eligible for FAA, so of the remaining 10 percent, 70 percent of that would come from the State, and 30 percent local. The estimated local share would be approximately \$25,000.

Berg motioned, seconded by Shogren, to approve the contract between the City of Cambridge and SEH for design work of the north apron at the Cambridge Airport. All voted aye, no nays, motion passed unanimously.

B. Approve Ordinance 782 Zoning Code updates to Section 156.041 & 156.064

Westover presented a request to amend Title XV Land Use, Chapter 156 Zoning, Sections 156.041 Industrial Districts & 156.064 Manufactured Homes and Manufactured Home Complexes; to continue the overall review to clarify language and correct any errors within the existing language as part of the overall review of the Zoning Code.

Westover continued, significant changes to note are: the Airport Zoning District was removed from allowed uses in the Industrial District, as there is a separate Airport Zoning District; maintenance facilities and auto towing were added to all I districts, and household waste processing was added to I-3 only.

The Planning Commission unanimously recommended approval of Ordinance 782 as presented with no changes.

Iverson motioned, seconded by Shogren, to approve Ordinance 782 as presented and allow for summary publication. All voted aye, no nays, motion passed unanimously.

C. Supplemental Request for Cambridge Fire Department

Benzen has identified some immediate needs of the Cambridge Fire Department (CFD) after being on staff for several months. Most of these are items that are not currently in the 2024 operating budget nor included in the department's long-range capital plan.

Benzen continued, CFD has five air pack units that are not compatible with the other 19. Replacement of these packs, masks and bottles is vital to promote fire firefighter safety.

Benzen continued, Isanti County Law Enforcement (LE) will be encrypting radio communications in 2024. When this occurs, CFD will no longer be able to hear any information from LE. CFD would like to purchase encryption capabilities for eight portable radios that were donated by Cambridge Police Department, along with the purchase and added encryption of three mobile radios for its command staff that will have encrypted transmission capability.

Isanti County is currently working on implementation of a new Computer Aided Dispatching system, Benzen said. When this project is complete, CFD will need equipment to access the new system. The department would like to request that each of the three command vehicles be outfitted with the proper tablet, mount, and software to allow access to call information while enroute and on scene. This system will also communicate with the State system where reporting occurs.

CFD has three full sets of extrication equipment but only one works well. The department would like to hire a grant writer to seek a grant to obtain another set. If the grant is received, there may be matching funds up to 5 percent.

Benzen said the total estimated cost for these needs is \$87,000.

Vogel asked Benzen to clarify if the request was for \$87,000 or \$50,000? Benzen said the total identified need was for \$87,000, but he was asking for \$50,000 for the provisions and an additional \$37,000 to aid in seeking donations and other funding sources.

Godfrey asked Moe if the request fit into the finance departments long-term plan, Moe said that the actions taken earlier in the meeting already moved funds to make this work.

Shogren corrected Benzen's staff report mentioned the County's new Computer Aided Design program, but it should have said Dispatching, not Design. Shogren asked Benzen if there would be one radio purchase for the mobile unit, Ross clarified he requested one radio and one mobile. Shogren asked if there were plans to purchase an earpiece? Benzen said that would be included. Shogren asked if Benzen would request from Council to purchase radios for other command staff in the future? Benzen said he would if that moves forward. Shogren clarified the radios would only be used for communication in the case of an emergency.

Shogren motioned, seconded by Iverson, to approve the supplemental request and direct finance staff to prepare budget revision and fund transfers to implement the supplemental request. All voted aye, no nays, motion passed unanimously.

D. Update to the Downtown Grant Fund

Smith said in the recently approved Downtown Interest Rate Subsidy Program eligible applicants may own a building or business in the B1 or B1-A district. Staff is requesting to update the guidelines of the Downtown Grant Fund Program to include the addition of the B1-A district to better match other programing available. This does not change anything financially but broadens the area for applications to better enhance a greater area around downtown.

Berg motioned, seconded by Shogren, to approve the recommended update to the Downtown Grant Fund program adding the B1-A district to eligible recipient area. All voted aye, no nays, motion passed unanimously.

E. Update to the Downtown Revolving Loan

Smith said staff is requesting to update the guidelines of the Downtown Revolving Loan Program to include the addition of the B1-A district similar to the request for the Grant Fund. The eligible improvement example section has also been updated to include roof repair or replacement, as well as clarifying wording. Applications may also be submitted by those leasing a building with written consent of the building owner. This loan is focused on updating the building, so if a business were to move, the upgraded building would still remain and be of benefit to the City.

In addition, Smith continued, staff are requesting \$300,000 be placed into the Revolving Loan Fund from the Redevelopment Fund. This would fund 10 approved projects at the maximum amount of \$30,000. If, at the end of a reasonable period of time, the program is not drawing interest the dollars can be moved back into the Redevelopment Fund.

Berg motioned, seconded by Shogren, to approve the recommended update to the Downtown Revolving Loan Program, including funding the program with \$300,000 from the Redevelopment Fund.

Moe clarified this action will take a future inter-fund resolution to move money from one fund to another.

Vogel explained this loan requires the security of a mortgage and promissory note, and would need to be completed by the building owner, not the lessee as mentioned previously. Smith said that was correct and she would modify the contract and remove "If the applicant does not own the building, written permission from the building owner is required."

Berg asked if a new building owner wanted to utilize funds before they fully own building, such as having a signed purchase agreement but not closed on yet. Vogel said they would have to wait until they owned the property to apply. The seller could agree to apply for the program, but that added complications.

Berg agreed to amend motion to remove "If the applicant does not own the building, written permission from the building owner is required" as discussed, Shogren agreed.

Upon vote, all voted aye, no nays. Motion passed unanimously.

F. Digital Marketing Opportunity for Consideration with CGI Digital

Vogel said he spoke with a representative from CGI Digital, a marketing organization that has a partnered with the National League of Cities (NLC). Through this partnership, CGI engages with cities of different sizes all over the country and provides, at no charge, digital marketing services in the form of a series of four one-minute video tours. The first video is usually an introductory video with the Mayor welcoming viewers to the City, and the other three can focus on anything Council would like such as housing, schools, downtown, economic opportunities, etc.

Vogel continued, the organization makes money by offering these digital marketing services at a charge to area businesses. Any business that chooses to engage CGI for services gets a link that is placed as a border around the City's videos. No business has any obligation to purchase services through CGI, and the City gets the video products at no charge regardless of whether or not any other businesses purchase services. The City can re-engage every three years in this service at no charge to ensure that the content is current.

Godfrey asked what the next steps would be if Council was interested in these services, Vogel suggested Council to make motion stating "Council authorizes the City to enter into an agreement with CGI Digital, pending approval by the City Attorney and City Administrator." This would allow for review of products and decide the scope of videos to produce. These would likely be filmed in spring or early summer. Godfrey asked if there has been any discussion with local business about their desire to be approached, Vogel said he has only brought this to Council, not local businesses.

Berg said there were videos on the City's website that highlighted the industrial park and important aspects of the City, Vogel said those have become outdated, non-compliant, and are no longer in use.

Iverson asked if CGI would contact businesses by phone or letter, Vogel said likely both.

Berg clarified the City would not share contact information for businesses, Vogel replied part of the agreement is sending out a letter to local businesses announcing the partnership and provide a warm welcome prior to CGI contacting them.

Shogren motioned, seconded by Iverson, to enter into an agreement with CGI Digital, pending approval by the City Attorney and City Administrator.

Shogren was in favor of the partnership, this is a legit business and businesses have the opportunity to say no if they are not interested in their services.

Upon vote, all voted aye, no nays. Motion passed unanimously.

Mayor's Report

A. State of the City

Godfrey reminded everyone of the State of the City luncheon to be held at First Baptist Church tomorrow, February 21st with check-in at 11:30 and presentation at Noon. Godfrey thanked those that had already registered to attend.

B. Winter Fest

Despite the lack of winter, Winter Fest will be held on Saturday, February 24, 2024. There are many snowman entries, seven vendors, touch-a-truck, chainsaw carving demonstrations, carriage rides, and more! Vogel noted the dog sled team will be present for questions, but does not have a wheeled option for rides. The horse carriage rides will be there.

Vogel said there would be a 50-degree difference from last year's Winter Fest and this year.

Vogel announced the City officially has its bonding bill for the Hwy 95 project jacketed. This bill is House File #3842, and will have significant impact on community as to whether or not the City receives State bonding appropriation or not.

Vogel said Councilmember Berg and himself testified today on House File #4009, the missing middle housing bill, which presents some concerning zoning preemptions for local governments. Vogel is trying to find constructive ways to engage other cities in coalition building, as this bill affects cities across the state.

Shogren asked if the Highway 95 bill has a Senate companion bill yet, Vogel said he was unsure but would research this. Shogren asked where Representative Johnson and Senator Koran were at on the Zoning bill, Vogel said Representative Johnson was the lead republican in the Housing Financing Policy Committee where the legislation was heard today. Vogel was told that Representative Johnson

supported change that increased the population requirements from 5,000 people to 10,000. Cambridge would still be included because its population is over 10,000.
