Cambridge City Council Meeting Minutes Monday, March 19, 2018

A regular meeting of the Cambridge City Council was held on Monday, March 19, 2018, at Cambridge City Hall Council Chambers, 300 3rd Avenue NE, Cambridge, Minnesota, 55008.

Members Present: Mayor Marlys Palmer; Council Members Kersten Conley, Joe

Morin, Jim Godfrey, and Lisa Iverson. All present, no absences.

Staff Present: City Administrator Woulfe, Police Chief Schuster, and Economic

Development Director Gustafson

Call to Order & Pledge of Allegiance

Palmer called the meeting to order at 6:01 pm and led the public in the Pledge of Allegiance.

Citizens Forum

No one signed up for the Citizens Forum.

Approval of the Agenda

Palmer requested to add 5A, Future Restaurant on Main St S to the Work Session and move the existing two items to items B and C. Iverson moved, seconded by Morin, to approve the agenda as amended. Motion carried unanimously.

Consent Agenda Approval

Godfrey pulled H & I for discussion. Iverson moved, seconded by Godfrey, to approve consent agenda Items A - G:

- A. Regular and Summary City Council Meeting Minutes for March 5, 2018
- B. Warrants #109600 #109812 and ACH/Wire items totaling \$1,097,586.98
- C. Approve Stormwater Maintenance Agreement with Menard, Inc.

Upon roll call Morin, Palmer, Conley, Godfrey, and Iverson voted aye, no nays. Motion carried unanimously.

- H. Approve Quit Claim Deed between City of Cambridge and Schlagel, Inc.
- I. Approve Pond Easement Agreement with Schlagel, Inc.

Godfrey explained items on the consent are usually items that were previously discussed by Council and he did not remember discussing these items. It was noted Godfrey was not in attendance at the Council meeting where it was originally presented to Council. Woulfe reviewed the staff report and confirmed the location of the pond easement.

Godfrey moved, seconded by Conley, to approve the Quit Claim Deed between the City of Cambridge and Schlagel, Inc. and the Pond Easement Agreement with Schlagel, Inc. Upon roll call Morin, Palmer, Conley, Godfrey, and Iverson voted aye, no nays. Motion carried unanimously.

Work Session

Future Restaurant on Main Street South

Palmer introduced Erick Harcey and Grant Johnson whom announced their plans for a new restaurant in Cambridge. Harcey and Johnson explained they have been in the planning stages and intend to open a restaurant, coffee house, and ice cream parlor in The Leader building. The plan is to repurpose half of the main floor space as Chef Erick's restaurant, with the restaurant in the front and the coffee house and ice cream parlor located more toward the back.

Johnson and Harcey hope to have the restaurant open in September since The Leader will be celebrating its 100-year anniversary the first week of November. Council welcomed back Cambridge natives Harcey and Johnson.

Community Wide Read Proclamation - "The Things They Carried" by Tim O'Brien

Palmer proclaimed March and April 2018 to be the One Book, One Community 2018 Reading Program. The book is *The Things They Carried.*

Information from TRIAD Meeting - Chief Todd Schuster

Schuster reported he attended the initial TRIAD meeting that was held at the Isanti County Sheriff's Office on February 27, 2018 and explained TRIAD is Senior Citizens and Law Enforcement working together to enhance senior safety. Schuster reported it was well attended by approximately 30 area seniors and announced the initial vision for the program is to have monthly meetings where some type of safety presentation is done.

Schuster reported the Cambridge Police Department has been running a "Senior Watch" program through the reserve program for a number of years now. The difference is that Senior Watch is typically a 1 on 1 interaction.

Schuster stated he believes that seniors living within Cambridge could benefit from attending the TRIAD meetings but the difficult part is notifying them of the dates / times of the meetings. Schuster proposed to accomplish this would be to visit with each senior living residence community and find a representative that he can get an email address for in order to forward the TRIAD meeting fliers to each contact who can then share the information with the residents.

Schuster stated he would also share the meeting dates with reserve officers that work with the Senior Watch program and invite them to take part and contribute as they can at the meetings. Schuster noted he would also plan on being at each monthly meeting

to represent the department and answer any city-specific questions that may arise. Council thanked staff for their participation.

Request to Change Title VII Traffic, Chapter 70 Traffic Regulations to Permit ATVs on City Streets

Schuster explained a request was made to allow the use of ATV's on the roadways for the purpose of snow removal. Currently, city ordinance does not allow for recreational motor vehicles (ATV's) to be operated upon any highway, public thoroughfare, alleyway or any other public property. It does allow for the use of recreational vehicles for the removal of snow from driveways or for routine yard maintenance.

Schuster reported the issue is coming before Council because during one of the heavy snowfalls in February, an officer saw an individual operating an ATV on the roadway and stopped the driver of the ATV to inform him of the ordinance violation. Schuster spoke with the owner of the company that the ATV driver was working for and advised him of the ordinance and explained that using the ATV's for snow removal on private properties was fine and that travel to adjacent properties would most likely not be an issue; the issue was travelling across town from one site to the next. Schuster stated he explained that in those cases, the ATV's would need to be trailered.

Schuster reported MN State Statute 84.928 regulates ATV operation on roadways but it does allow, local governments to write local ordinances that are less strict than the state law. Schuster stated the City of Isanti has done this and their ordinance allows for the user of a motorized golf cart or ATV to purchase an annual permit. Once several conditions are met, the permit holder is then allowed to operate their ATV only on city streets, not county, state or federal highways. They can also only be operated from sunrise to sunset and not when there is inclement weather.

Schuster stated his personal recommendation is to leave the ordinance alone since it was written to govern the use of ATV's all year long. His recommendation is that if a snow removal company is going to utilize ATV's as part of their snow removal force, the City allow them to operate the ATV's on each private parking lot that they are removing the snow from and to travel to an adjacent property to remove snow if it can be done without travelling on a roadway. If roadway travel is necessary, his recommendation is to trailer the ATV. Council took no action and was not interested in changing the ordinance.

Unfinished Business

Approve Additional Downtown Grant Funds for Mo Millie Salon, Emily Pearson, 235 Main Street South

Gustafson stated the applicant is replacing one more window for a total of \$1,305.80 and is requesting an additional \$629.90 in Grant Funds which is 50% of the cost and the property owner will be covering their portion of \$629.90. Gustafson reported the original request in grant funds was for \$3,339.40 and with the additional \$629.90 will make the total grant amount \$3,969.30 to make improvements to the façade. The estimated

project cost is \$7,984.60 for store front improvements including awnings and window replacement.

Gustafson stated based on the guidelines established by the City Council for the Cambridge Downtown Grant Fund, this project meets the guidelines and provides updates and repairs to the façade that will provide a visual improvement which is a goal for this program and downtown beatification. Gustafson noted all necessary building, signage and/or electrical permits must be applied for and inspections will be conducted as required by the permit and upon request for payment.

Gustafson stated payment will be issued to the contractors upon completion of their work paid out at 50% from the City and the property owner is responsible for the remaining 50% and any amount that would exceed the maximum grant amount of \$629.90. Gustafson noted, the project will start once approved and the project must be completed by December 31, 2018.

Conley moved, seconded by Iverson to approve an additional \$629.90 in grant funds for a total grant amount of \$3,969.30 Cambridge Downtown Grant Funds to Mo Millie Salon 235 Main St SW, Cambridge, MN. Motion carried unanimously.

Cambridge Public Library Construction Project

Palmer gave a review of the Library Task Force meeting that took place prior to the City Council meeting that day. Palmer reported the Library Task Force voted on and ultimately passed 9-0 with 1 abstention the following recommendation to City Council, "not to pick a specific location right now, but to direct staff to research property locations with a close proximity to the core downtown area on which to build an advanced level of service library as stated in the Leo A. Daly Library Feasibility Report."

Isanti County Commissioner Susan Morris stated the Library Task Force is committed to revitalizing downtown and supports the library to stay in the downtown area.

Bob Roby owner of Minnesota Mediation Services which is located in the downtown area thanked the Library Task Force for their recommendation.

Council discussed feedback they individually received from community members. Although some preferred the Heritage Greens location, there was more support from people they spoke to for the library to remain downtown.

Godfrey moved, seconded by Morin to accept the recommendation from the Library Task Force and direct staff to continue to educate on the referendum for the library needs, parks, and street improvements. Motion carried unanimously.

Iverson moved, seconded by Morin, to recess from 7:22 pm to 7:32 pm. Motion carried unanimously.

Woulfe reported one of her goals for 2018 is to update City Code Title V Public Works, Title VII Traffic Code, and Title XI Business Regulations. Woulfe explained she has started with Title XI Business Regulations and gave a summary of the changes for each chapter. Woulfe noted all changes have been reviewed by City Attorney Squires. Woulfe identified three amendments from the original ordinances that were in the Council packet. The amount in 115.02 Definitions Loosies, the cost was lowered from \$2.00 to \$1.00. In 115.06 (C) Smoking Lounges, the words "However, the licensed establishment is permitted to set up and test new devices for customers purchasing new tobacco, electronic cigarettes, electronic delivery device or nicotine or lobelia delivery devices." In 115.06 (D) Cigars, the cost was lowered from \$2.60 to \$1.00 per cigar. Woulfe reported these changes were made because of a request received from a local business and was approved by the City Attorney. Woulfe noted these recommended changes to the City Code came from the League of Minnesota Cities.

Schuster stated in order to issue administrative citations and submit them electronically for charging, all violations need to have a code associated with them that is assigned by the court administration office. In order for a code to be issued, there needs to be a fine associated with the ordinance for prosecutorial reasons. Schuster reported they had several local ordinance violations in our ticket writer list that needed codes so they can write citations for those violations, but previously had no fines associated with them.

Woulfe noted the proposed ordinances were properly posted on the website and bulletin board as required by statute and sent to tobacco and alcohol license holders as required.

Godfrey moved, seconded by Conley, to approve Ordinances 665 – Amending Ordinance 658 Establishing Fees for Police Citations, Ordinance 666 – Amending Title XI Business Regulations, Chapter 118 Adult Establishments, Ordinance 667 – Amending Title XI Business Regulations, Chapter 110 Issuance of Licenses and Permits, Ordinance 668 – Amending Title XI Business Regulations, Chapter 115 Tobacco and Tobacco Related Devices, Ordinance 669 – Title XI Business Regulations, Chapter 111 General Business Regulations, Ordinance 670 – Title XI Business Regulations, Chapter 112 Peddlers and Solicitors, Ordinance 671 – Amending Title XI

Business Regulations, Chapter 114 Alcoholic Beverages as amended by staff. Motion carried unanimously.

Library Task Force Membership Request – Kathy McCully

Woulfe explained Kathleen McCully has requested City Council appoint her to the Library Task Force. Woulfe reviewed her bio that she submitted. Woulfe noted, with the exception of Lynne Dablow, who is representing the Isanti County Historical Society, the current members of the task force either live in town or represent a business in town. McCully does not live within the City limits but had a long tenure at the Isanti County Historical Society and is very familiar with the library and the Cambridge community.

Council discussed the fact McCully is not a Cambridge resident and the impact that could have considering the referendum vote is only available to Cambridge residents.

Godfrey moved, seconded by Morin, to decline appointing Kathy McCully with regrets due to non-residency. Motion carried unanimously.

Iverson moved, seconded by Morin, to allow Iverson and Morin to attend the conference in St. Cloud. Motion carried unanimously.
