

Cambridge City Council Meeting Minutes
Monday, April 17, 2017

A regular meeting of the Cambridge City Council was held on Monday, April 17, 2017, at Cambridge City Hall Council Chambers, 300 3rd Avenue NE, Cambridge, Minnesota, 55008.

Members Present: Mayor Marlys Palmer; Council Members Kersten Conley, Joe Morin, and Jim Godfrey. All present, no absences.

Staff Present: City Administrator Lynda Woulfe and Community Development Administrative Assistant Carri Levitski

Call to Order & Pledge of Allegiance

Palmer called the meeting to order at 6:00 pm and led the public in the Pledge of Allegiance.

Citizens Forum

No citizens addressed the City Council.

Approval of the Agenda

Woulfe added item F under New Business: MnDOT Signal Agreements. It was also noted the correct address directional under Consent item 4B for was SW, not SE. Morin moved, seconded by Godfrey, to approve the agenda as amended. Motion carried unanimously.

Consent Agenda

Iverson moved, seconded by Conley, to approve consent agenda Items A-E:

- A. Regular and Summary City Council Meeting Minutes for April 3, 2017
- B. Purchase Agreement for 744 3rd Avenue SE
- C. Resolution R17-021 Accepting donations to Cambridge Fire Department for Equipment
- D. Warrants #105486 - #105708, Cashier's Check and ACH/Wire items totaling \$983,045.84
- E. Approve Filling Public Works/Utilities Seasonal Employee Positions

Godfrey noted that in an email Morin asked for further explanation on the expenditure item 978 - payment of \$702.00 to Carlson & Stewart Refrigeration for Ice Rink – Repair and Maintenance Labor and the reason for the expenditure was explained in an email to all Councilmembers. Upon call of the roll Morin, Palmer, Conley, Iverson, and Godfrey voted aye, no nays. Motion carried unanimously.

Work Session

There were no items for the work session.

Unfinished Business

Contract with Balancing Act for Taxpayer Receipt and Balancing Act PRO Budget Simulation

Woulfe explained at the City Council visioning session, the Council discussed different ways to engage the citizens in discussions on the City budget and levy. The Council reviewed the

pros and cons of contracting with Balancing Act for the taxpayer receipt and budget simulation tools. Woulfe reported Council directed staff to seek pricing from Balancing Act and bring it back to Council for approval in time to get the simulation ready for the 2018 budget preparation cycle. Woulfe reviewed the costs and what the software's provide.

Morin moved, seconded by Conley, to authorize a one-year subscription to Balancing Act for Taxpayer Receipt and Balancing Act PRO Budget Simulation and directed staff to implement the cost in the upcoming 2018 budget preparation cycle including the staff hours for customization not to exceed \$500. Motion carried unanimously.

New Business

Renewal of Local Pawn's Pawnbrokers License

Levitski explained the City of Cambridge pawnbroker's licenses run the calendar year (January – December) per City Code, but in the past, Local Pawn's license has been running April to May. Levitski reported she caught it this year so she is asking for a renewal for the remainder of 2017 with a pro-rated license fee (\$2,000). Levitski stated they will apply for their renewal this fall for all of 2018. Levitski stated Local Pawn has filed all the required paperwork and all the background checks have passed and noted the Police Department is supportive of the request.

Conley moved, seconded by Iverson, to approve Local Pawn's Pawnbroker's License from May 1 – December 31, 2017. Motion carried unanimously.

Enhanced Remote Access Agreement – Isanti County Recorder's Office

Levitski explained LandShark is the electronic document retention program through the Isanti County Recorder's office and all documents that have been recorded on a property dating back to 1980 are available on the software with more documents being added.

Levitski explained the process of accessing documents which requires staff to travel to the Isanti County Government center on a regular basis. Levitski reported copies at the courthouse are \$1.00 each and by using LandShark, it will cost \$0.25 per page to view and print documents which will save staff time and copy cost. Levitski noted copies of plats the City currently does not have, the cost is still \$10 per page.

Levitski reviewed the cost of LandShark which has an initial account set-up fee of \$50 and a subscription cost of \$50 per month. Levitski reported usually the \$50 monthly fee covers two staff and there is an additional \$10/user fee, but as a courtesy from the County to the City, they will charge us a maximum fee of \$50 per month with no additional cost per user.

Levitski stated there are currently funds available from line items that will cover the cost for the remaining of 2017 and if staff continues the online service, the cost will be worked into the 2018 budget.

Godfrey moved, seconded by Iverson, to approve the Enhanced Remote Access Agreement with the Isanti County Recorder's Office and use the cost of the subscription out of the

current budget and directed staff to revisit at the end of December 31, 2017. Motion carried unanimously.

***Approve Resolution No. R17-022 Approving a Preliminary Plat for the Cortec Addition
Approve Resolution R17-023 Approving a Final Plat for Cortec Addition***

Woulfe stated Miksic Realty is the owner of Cortec and they are requesting approval of a preliminary plat for Cortec Addition. Woulfe informed Council they have plans to expand their warehouse with an addition to the building on the north end of their property but due to the complexity of their existing property lines, they have requested to plat their property.

Tim Bliss and Cindy Baker, representatives from Cortec reviewed their project with Council.

Woulfe reported the Planning Commission at their regular meeting on April 4, 2017, voted unanimously to approve Cortec Addition Preliminary and Final Plat provided the conditions as listed below were met.

Woulfe noted that City Attorney Squires would like to see two additional conditions added to the resolution. They are:

4. The plat shall include all the drainage and utility easements required by the City as part of the site plan approval.
5. The applicant shall obtain necessary easement to connect applicant's storm sewer pond to the City pond to the north of the applicant's property.

Morin moved, seconded by Godfrey, to approve Resolution R17-022 Approving a Preliminary Plat for the Cortec Addition and Resolution R17-023 Approving a Final Plat for the Cortec Addition provided the following conditions are met:

1. The applicant has filed a Site Plan Review application with the City for site work and an addition to be done. The Site Plan Review must be completed to the satisfaction of the City prior to the building permit being issued.
2. The Final Plat must be recorded with the Isanti County Recorder's Office within 30 days of approval from the city.
3. A copy of the recorded final plat must be submitted to the City within 5 days of recording.
4. The plat shall include all the drainage and utility easements required by the City as part of the site plan approval.
5. The applicant shall obtain necessary easement to connect applicant's storm sewer pond to the City pond to the north of the applicant's property.

Motion carried unanimously.

Request to Amend Nuisance Ordinance - Noise

Sean Okerlund, owner of the Cambridge Bar & Grill appeared before Council and requested they reconsider the noise ordinance as it relates to downtown events put on by local businesses. Okerlund reported they hosted an inaugural block party on July 29th last year and

they are in the planning stages for their outside events for this summer. Okerlund explained the events cost a lot of money to hire bands, rent a stage, tables, chairs, tents, security, generator, etc. These expenses are a large investment from the business owner's perspective. Okerlund reported he spent over \$4,000 on direct expenses at least year's event. Okerlund stated the public begins to show up about 8:30 pm and with the current noise ordinance restriction, it gives the owner only 90 minutes to try and recoup their investment. Okerlund requested the Council move the timeframe to either 11:00 pm or 12:00 am to give the business additional time for sales.

Discussion ensued by Council and it was the consensus they need to have a maximum number of events held to be mindful of the residential homes in the downtown area. Council confirmed the police department has no issue with this request and there were no calls resulting from last year's event at the Cambridge Bar and Grill. Woulfe stated events would be reviewed as part of the Street Closure Request process and the police department receives all the street closure requests. Woulfe also noted that if an event did go badly, the Council would have discretion to not approve any future street closure requests from that business.

It was the consensus of Council to amend the last paragraph in the ordinance to read: A property owner in the B-1 Downtown Business District that holds a valid liquor license issued by the City may request as part of the street closure process to hold a single day event that would generate noise until 11:00 pm. The Council may allow up to six (6) such events per year in the B-1 Downtown Business District with a maximum of two events per licensed establishment. Council directed staff to bring back the ordinance amendment and place on the consent agenda.

MnDOT Signal Agreement SP 3003-47 & SP 3003-6X (TH 65)

Woulfe explained the City is responsible for maintaining all of the traffic signals in town even though some are on a state highway. Woulfe continued explaining when the traffic signals are placed the City enters into a maintenance agreement with Minnesota Department of Transportation (MnDOT). Woulfe reported the signal at Highway 65 and Main Street at the south end of town is in desperate need of painting and maintenance. Woulfe stated if they enter into contract with the State the cost is \$8,100 and noted there are funds budgeted for this amount. Woulfe reported Schwab requested proposals from independent contractors for the City to do the work and the cost with the state is consistent with the quotes he received.

Conley moved, seconded by Morin, to approve the agreements as presented and authorized the City Administrator to execute the agreement. Motion carried unanimously.

Mayor's Report

Palmer provided an update on meetings attended and upcoming meetings and events.

Council Concerns

There were no Council Concerns.

City Attorney's Report

Squires gave a briefing since the last meeting.

City Administrator's Report

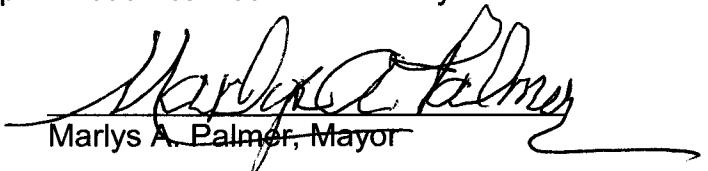
Woulfe closed the open meeting at 7:30 pm and announced Council will not reconvene following the closed session.
